**Licensing Procedures and Guidance** 

This Guidance is to assist providers with transitioning to the Waiver Re-design. Providers will continue to transition until June 30, 2017. Therefore, this plan will stay <u>effective until June 30, 2017</u>.

- 1. Providers *with current DBHDS Center Based-Day Support Licenses* should start submitting service modification forms to the Office of Licensing as soon as possible, if they plan to access one of the new waiver reimbursable options requiring a Non-Center Based Day Support License.
  - a. The service modification are accessible at: <u>http://www.dbhds.virginia.gov/professionals-and-service-providers/licensing/licensing-application</u> (Under the Service Modification Tab)
- 2. Providers with *current DBHDS Center Based-Day Support Licenses* wanting to obtain a Non-Center Based Day Support License will have to submit the following with their service modification request:
  - a. A service description
  - b. Staffing patterns
- 3. With each service modification request to add a license/service the licensing specialist will conduct an onsite visit to review the added service/license.
- 4. The remaining information will be reviewed by the licensing specialist during their initial site visit and during their 6-month conditional license status.

- a. Providers with current DBHDS Licenses adding additional services will be issued a conditional license for the "new service." This does not trigger enhanced case management because the provider's organizational license remains intact. This is not a change in current processes.
- 5. Providers not licensed by DBHDS previously providing pre-vocational services through DARs, but prefer to start offering Day Support Services will have to submit an application to be licensed by DBHDS. These applications are treated as priority reviews. We encourage these vendors to note if they were previously associated with DARs. - Providers licensed by DBHDS previously providing pre-vocational services through DARs and did not hold a Day Support License, but want to start offering Day Support Services will have to submit *all necessary documents* with the service modification form accessed online at: <u>http://www.dbhds.virginia.gov/professionals-and-service-</u> <u>providers/licensing/licensing-application</u> (Under the Service Modification Tab)
- 7. Above is a matrix of which licenses are needed for the waiver options.

DD case management participation in the amended waivers

Private DD case management providers will be able to contract with a CSB/BHA (Community Services Boards/Behavioral Health Authority). Virginia CSBs/BHAs are currently prepared to engage private DD providers.

CSBs/BHAs should notify their assigned licensing specialist/Office of Licensing if these partnerships result in a change in the organization or staffing arrangements. The notification should be made using a service modification application.
