CENTRAL VIRGINIA TRAINING CENTER (CLOSED)



The 386.53 acre site is located in Madison Heights on the James River immediately across the river from Lynchburg.

The facility includes 89 numbered buildings, 1 swimming pool and 2 water towers.

Utilities:

- The City of Lynchburg provides both water service.
- Amherst County provides sewer service.
- Appalachian Power Company provides electrical service.
- Verizon provides telecommunications services.

The site contains several buildings of historic character and two cemeteries.

Operations began in 1910 as the Virginia State Colony for Epileptics. The campus footprint and services were expanded significantly in the 1940s and 1950s. Resident and staff population peaked in the 1970s. This facility was closed in 2020 and has been fully vacated, and the buildings are unused.

It is anticipated that the buildings will be demolished for redevelopment for new industry.

Lower Rapidan Buildings

Converting to Skilled Nursing Beds:

Buildings are in relatively good shape; equipment is between 10-16 years old; bedrooms have headwall units for gas & vacuum

Buildings share common bathrooms for multiple bedrooms. Laundry will have to be reconfigured to separate clean & soiled linens. HVAC capacity would have to be evaluated. Extensive redesign likely to meet current certification requirements and to update to current building codes.
