TACKLING ABUSE AND NEGLECT

- dLCV responds to allegations and monitors conditions to address abuse and neglect
- dLCV receives hundreds of incident reports from state facilities each year
- dLCV reviews and investigates reports from Adult Protective Services and Psychiatric Residential Treatment Facilities
- We appealed to the United States Supreme Court to maintain our authority to protect the safety of people with disabilities in state institutions.
