#### What is CONNECT?

- CONNECT is the licensing management software utilized by the Department of Behavioral Health and Developmental Services.
- The CONNECT Provider Portal allows providers to electronically submit all required paperwork such as an initial applications for a new provider, license renewal applications, service modifications and variances. Providers can also manage authorized contacts and communicate directly with DBHDS staff.
